The poet N. Lakshminarayanappa, who is popularly known as Kavi Muddana, lived in Nandalike

village, Karkala taluk, Udupi district.The coin was brought out on the occasion of the 150th birth anniversary of Kavi Muddana who was born on January 24, 1870. He died early, at the age of 31. He is the author of highly acclaimed Yakshagana works and epic poems. His works in Kannada and in Sanskrit are known for their lyrical quality. Some of his major works include Ratnavathi Kalyana, Kumara Vijaya, Sri Rama Pattabhisheka, Sri Ramashwamedha and Adbhuta Ramayana.



#### **Metal Detectorist Discovers One of England's Earliest Gold Coins in a Farm Field**

n amateur metal detectorist unearthed a rare medieval gold coin on farmland in Devon, England, reports Sana Noor Haq for CNN Style. Coin experts speculate the 800-year-old Henry III gold penny could sell for around \$546,000 at an online auction.

Minted around 1257, the nearly oneinch coin depicts the English king, who ruled from 1216 to 1272, sitting on an ornate throne while holding an orb and scepter. It is considered by experts to be one of the earliest gold coins found in England; only seven other coins of this type are known to exist, per Nadeem Badshah of the Times.

The other surviving Henry III gold pennies are at the British Museum in London, Fitzwilliam Museum in Cambridge and in private collections, reports Alexandra Markovich for the U.S. Sun.

The finder, an ecologist who chose to remain anonymous, didn't realize the coin was so valuable, but he posted a photo of it on Facebook, where a specialist spotted it. "I just happened to see it there and I got in touch to tell him he had to get it assessed," Gregory Edmund, an auctioneer at Spink & Son, which is conducting the sale. tells the Times.

Edmund adds that the introduction of gold coins during medieval times "shows the direct influence on daily life of the international trade routes from the gold-rich Middle East and North Africa."

The ecologist says he was working on a farm field in the town of Hemyock-about 150 miles southwest of London-when his metal detector started pinging, per the Times. He soon realized the significance of his discovery.

"I want to be able to understand more about who I am, and where I have come from. Metal detecting helps me to do this," he says in a statement. "It has also ultimately saved this magnificent coin from the plough blade. How it has survived three-quarters of a millennium relatively unscathed is truly miraculous."

According to the Times, around 1240, Henry III proclaimed payments to the crown be made in gold rather than silver to fund foreign wars. The one of the foundational documents of modern Western democracy.

Auctioneer Spink & Son placed the presale estimate for the coin at \$546,000. Last year, another Henry III gold penny sold for \$720,000 at an auction in Dallas, Texas, to an unnamed bidder, per This Is Money. Often, the United Kingdom takes possession of antiquities discovered by civilians, offering them a portion of proceeds from the sale to interested British museums. However, under the Treasure Act of



pennies were minted around 1257 by William of Gloucester with gold from North Africa, writes David Carpenter, professor of medieval history at King's College London, in the Spink & Son's catalog.

Henry III, also known as Henry of Winchester, became king of England at nine years old after the death of King John in 1216, reported George Nixon of This Is Money in a 2021 article.

Like his father, Henry reissued and signed the Magna Carta, which guaranteed certain legal and property rights, to quell unrest among the English barons. Historians recognize his version of the charter as

1996, the finder can keep and sell the artifact if it is not believed to be part of a larger trove of items, reports CNN Style.

The discoverer says he plans to use the money from the auction for his children's future, per the Times. He is thrilled that he was the one to find the 800-year-old coin and help preserve it.

"Now it is protected for future generations to enjoy and it is truly humbling that I was its finder," he says in the statement. "Like every hobbyist who continues to dream, my wish that day came true, and I just happened to be the very fortunate one."

#### Mint Statistics: Negro Leagues Baseball Coins Kick Off 2022

The calendar has flipped to 2022, and U.S. Mint products have come out of the gate strong in the new year.

It's clear that the silver dollar carrying the "100" privy mark was the first to catch collectors' eye. It has sold out of its 20,000-piece mintage. Another popular option is proving to be the proof version of the clad half dollar with a total nearing 9,000. Close behind is the proof silver dollar at just over 8,300. The two more expensive options, the gold \$5 proof and uncirculated coins, have posted the lowest sales totals thus far.

The start of the year marks a new cycle of bullion sales, and things are off to a strong start. Silver bullion Eagles have already crossed the 3.5 million mark, while all sizes of gold bullion Eagles are on the board with decent totals. In all, 333,500 of the gold Eagles have been sold. One-



ounce proof Buffalo bullion sales have reached 42,000 so far.

### Henry VII Coin Unearthed in Canada

small silver coin found at the Cupids Cove Plantation Provincial Historic Site in eastern Newfoundland may be the oldest English coin ever found in North America.

The coin, discovered during the latest season of annual excavations at the site, is a Henry VII 'half groat', believed to have been minted in Canterbury, UK, sometime between 1493 and 1499.

The colony at Cupids Cove Plantation was established in 1610 by John Guy, a merchant from Bristol, and is one of the earliest English settlements in



North America. But this coin was in circulation for many years and must have passed through many hands before it was lost here in the early



17th century, thousands of miles from the town where it was minted more than a century earlier.

#### The 1838 - O Half Dollar

ertainly rare and equally historic, the 1838-O half dollar is a coin that is not often offered for sale, making its price something of a question mark, especially at a time when a lot more available coins, although admittedly high in grades, are making the \$1

million price barrier seem like less of a barrier and more of a routine benchmark on their way to far higher prices.

The 1838-O half dollar is part of the story of the New Orleans facility. Back in the mid-1830s, there was a drive to approve the first branch mints. There had been a major gold discovery in Georgia and North Carolina. Because there wasn't an interstate system at the time, it was no small task to transport that gold to Philadelphia. It was much easier and safer to simply have a facility on the spot to process the gold and make it into coins. That saw the approval of facilities in Dahlonega, Ga., and Charlotte, N.C.

While Congress was in an approving mood, it voted to approve another facility as well: New Orleans. There had been no major gold discovery in New Orleans. The gold in New Orleans was the ground itself – the city wanted a mint and offered the government a piece of prime real estate. It was too good to refuse and, realistically, a New Orleans facility made sense. It was a transportation center that could not only receive precious metals, but also turn those metals into coins that could easily be

distributed all over the country. From the start, New Orleans was seen as different from Dahlonega and Charlotte. New Orleans would make both silver and gold coins, while the other two were only able to produce gold coins. Moreover, New Orleans served a much larger

area, and even the gold coins of New Orleans would be more diverse. It would produce gold eagles and double eagles, while Charlotte and Dahlonega would never produce a denomination higher than a \$5 half eagle. There was apparentl y a great deal of enthusias m in New Orleans for

Orleans for the idea of a mint. In fact, it appears that there were a

couple ceremonial strikings to mark the mint's opening as there was a May 7-8 release of 30 dimes in 1838. There was also a striking of some 1838-O half dollars, most likely to test the equipment.

1838

We don't know whether those half dollars were struck in 1838 or 1839 since there is no report of an 1838 mintage. The simple truth is we do not know the mintage. Back in 1894, there was speculation that it was only a few pieces while others contended it might be a dozen. The chief coiner at the New Orleans facility at the time, Rufus Tyler, is quoted as saying it was "not more than 20 pieces." The problem is that total only sets a high end and still leaves room for debate. As a result, many have simply accepted the figure of 20, though we really are not certain.

The uncertainty as to the actual mintage does not hurt interest in the 1838-O. It is a proof, which is special since it was the first branch mint proof. It is also the first half dollar produced at New Orleans. Then, to top it off, it is rare. The best guess is that there is nine known today. An example came up for auction in 2019 and sold for more than \$500,000.

The question is how high the 1838-O might go in the future. With nine known, \$1 million might be slightly high, but there are other factors, such as its historical importance, that have to be factored into any potential prices. We have seen historically important coins with far more than nine examples known reach \$1 million. It will be interesting to watch where the 1838-O half dollar goes from here.

#### Stamp Honouring Permanent Commission to Women Officers in Army Released

ew Delhi: Army Chief General MM Naravane on 15th January, 2022 released a postage stamp commemorating permanent commission to women officers in the Army. The Supreme Court, in a landmark ruling in February 2020, had directed the Centre to ensure that women short service commission (SSC) officers are given permanent commission in the Army, including command postings.

The Army tweeted, "On the occasion of Army Day, General MM Naravane, Chief of Army Staff, released a commemorative postage stamp, 'Permanent Commission to Women Officers in the Indian Army'."

After the Supreme Court ruling, the Army had constituted a special selection board in September, 2020 to screen women officers. The results were declared in November, 2020.

moved the top court. In March, 2021, the court found that the "evaluation criteria set by the Army constituted systemic discrimination" against these women officers. The top court, in its March 2021 order, laid down revised parameters on the basis of which the women officers were evaluated for permanent commission in the Army.

Thereafter, in July, 2021, a total of 147 additional women SSC officers of the Army were granted permanent commission according to the revised parameters set by the Supreme Court.
