TERMS & CONDITIONS ARE AS FOLLOWS:

INDIAN COINS & CURRENCY GROUP (ICCG) is **Numismatics group providing information and advice about Numismatics** (which means scientific analysis and study of money and the use to which people invest their money throughout history and its collection). When collectors use the word numismatics, though, they generally mean the study of coins/currency in particular, in wider sense more correct definition includes the study and collecting of all money-related items such as Coin-sets (UNC/Proof), banknotes, tokens, medals, bullion rounds, etc.

A MEMBER OF INDIAN COINS & CURRENCY GROUP (ICCG) shall mean:

A member shall mean and include the definition of **NUMISMATIST**.

Membership shall be for the period of three years from the date of issue of the membership card and same can be renewed at the time of expiry of the membership subscription for furnishing information and guidelines by paying membership charges at prevailing rates.

Person/s making the application shall be an Indian Citizen and shall complete the age of majority i.e. **18 years of age and should be of sound mind.**

If any minor wants to take membership the same shall be made through his/her legal/natural Guardian only.

The member shall take appropriate license from the authorities for dealing in antiques as provided under The Antiquities and Art Treasures Act, 1972 and Antiquities and Art Treasure Rules 1973 and THE INDIAN COINAGE ACT, 1906, and Reserve Bank of India ACT, 1934 as amended up to date.

The person/s seeking the membership shall abide and follow all rules, regulations' and guidelines of the Government of India, RBI and any other authorities from time to time with regards to antiques and treasures.

Any member who wishes to carry his/her collection for display in any exhibition should obtain prior permission from the respective authorities and further also obtain invitation/permission letter from the exhibitor.

The subject matter of membership shall be at the sole discretion of ICCG and their decision will be final and the same shall not be subject to any kind of challenge in any court of law.

The member shall not hold ICCG responsible if any of its members buys, sells or deals in any fake or counterfeit currencies, coins, replica etc. and further declares that the ICCG is only providing information and it shall not be held responsible if any of its members deals or is involved in any business of buying and selling of coins and currency without proper license and /or beyond the scope of law governing the buying and selling of antiques and treasures.

The complimentary services of ICCG are subject to and valid only for its members residing in India.

Member shall further note that the ICCG shall not be responsible for any non delivery of Notifications of various events, etc., sent by via text messages and emails and are subject to only the members residing in India and in accordance with Rules and Regulations laid down by the relevant authorities from the time to time.

NO complaints with regards to the same shall not be entertained beyond the scope of Law.

A Member shall cease to be member of the ICCG.

- 1) On resignation or death or becomes unsound of mind.
- 2) If in the opinion of ICCG the conduct of any members is prejudice or adjudges to be detrimental to the interest of the group.
- 3) Any member is guilty of misconduct which is in the unanimous opinion of the Management of the ICCG likely to affect adversely the harmony and the prestige of the group.
- 4) Any member is proclaimed offender or convicted by the competent court of law for 2 years or more.
- 5) Any member indulges himself/herself into buying, selling or dealing in any fake or counterfeit currencies, coins, replica etc.
- 6) Any member is involved into illegal practices of dealing in foreign exchange and Indian currencies without proper permissions from the Government of India.
- 7) If the member doesn't act in accordance with the rules, regulations and guidelines frame by the Governing authorities/Government authorities/Semi-government authorities etc.

In any event membership subscription shall not be refunded once application has been made by the individual seeking membership of the ICCG.

ICCG reserves the right to amend/rectify/change any rules and/ or close the group without prior notification to its members.

ICCG is the proprietary concern providing facilities and information to its members which are subject matter of knowledge and information gathered single handedly and if any dispute arises between members the same shall be referred to sole arbitrator appointed by ICCG as per the Arbitration and conciliation Act, 1996 as amended up to date and shall be subject to Mumbai Jurisdiction.
